This year the following elected offices are available (elections occur in August 2019).

- **President-Elect** (3 year commitment)
- **Secretary** (2-year term)
- **Director-at-Large** (2-year term; 1 position up for election in Public Relations)

See below for brief descriptions of each of the positions available. All nominees must be current members of NVSHIP.

President-Elect - The presidential office is a three-year commitment. The President-Elect shall perform the duties of the President when the President is unable to do so. The President-Elect shall be a member of the Board of Directors (attend annual meeting and strategic planning annually) and serve as its Vice Chair and shall assume other responsibilities as directed by the President. The President-Elect shall serve a one year term of office in this capacity and shall assume the office of the President at the next installation of officers. He/she shall establish, with the approval of the Board of Directors, goals and objectives for NVSHIP for the term of office as President and will assist the Treasurer with drafting a budget and dues schedule for the next fiscal year. After serving the term of President, the Immediate Past President chairs the Awards and Nominations Committee.

Secretary – The Secretary is an integral part of the Board of Directors and is responsible for communication within the Board and with our members. The Secretary shall learn to manage the announcements and communication on our website. The Secretary shall be a member of the Board of Directors, attend the Annual meeting, attend Strategic planning annually, and prepare the agenda and minutes for the Board of Directors. The Secretary will serve a two-year term of office in this capacity.

Director-at-Large - The Director-at-Large shall serve as member of the Board of Directors of NVSHIP (attend annual meeting and Strategic planning annually). Each Director-at-Large shall assume responsibility as liaison of a standing or special committee as appointed by the President. Each Director-at-Large shall serve a two-year term of office and shall be permitted to stand for re-election as Director or to be a candidate for any elective offices in NVSHIP in any constituted election. This specific Director-at-Large spearheads our annual Student Symposium, quarterly newsletter, and social activities.

Remember that NVSHIP will only continue to succeed with strong support from leaders, volunteers, and members! Please nominate yourself or another member who you feel would be an asset to NVSHIP. See the attached nomination form in this email.
