# Medication Reconciliation National Patient Safety Goal to be Reviewed, Refined

Medication errors continue to be one of the most frequent causes of preventable harms in health care. The Joint Commission is committed to helping organizations prevent medication errors, as evidenced by our National Patient Safety Goal on medication reconciliation, which highlights a critical problem that poses significant risk to patients. However, since the Goal on medication reconciliation was instituted in 2005, many organizations have struggled to develop and implement effective and efficient processes to meet the intent of the Goal.

Today, The Joint Commission Accreditation Committee determined that effective January 1, 2009, survey findings on National Patient Safety Goal 8 (Accurately and completely reconcile medications across the continuum of

care) will continue to be evaluated during the onsite survey. However, given the difficulties that many organizations are having in meeting the complex requirements of NPSG 8, the Accreditation Committee agreed that The Joint Commission should evaluate and refine the expectations for accredited organizations. While this evaluation is being conducted, survey findings from NPSG 8 will not be factored into the organization's accreditation decision. In addition, survey findings on NPSG 8 will not generate Requirements for Improvement (RFIs) and will not appear on the accreditation report.

Recognizing that medication reconciliation problems continue to put patients at risk, The Joint Commission expects organizations to continue to address medication reconciliation within their organizations. During the onsite survey, Joint Commission surveyors will evaluate the organization's medication reconciliation processes, discuss opportunities for improvement, and collect information on the progress organizations are making in meeting NPSG 8.

In 2009, The Joint Commission will evaluate and further refine NPSG 8. As part of this process, The Joint Commission will consult with health care organizations, physicians, pharmacists, nurses, surveyors, and other stakeholders. Through these discussions, an improved NPSG 8 will be crafted that both supports quality and safety of care and can be more readily implemented by the field in 2010.

# Student Article: Nevada Pharmacists and Student Pharmacists push for change.

Currently Nevada is one of three states (Arizona, Nevada, and New York) that does not allow for a pharmacist to take a patient's blood glucose level. In a combined effort, a senate bill has been proposed that will hopefully change this law and allow for pharmacists and student pharmacists to perform blood glucose tests.

On February 18th, 2009, several pharmacists, student pharmacists, patients, and community members attended an open legislative hearing to show support for the bill SB 72. In addition, several members present at the hearing had the opportunity to testify in support of the bill. Amongst those who testified was Dr. Renee Coffman, Dean of the University of Southern Nevada College of Pharmacy (USN COP). Dean Coffman was able to address the concerns over the lack of training and knowledge that pharmacists have regarding diabetes disease state management and screening. She also emphasized that a pharmacist performing a finger stick would then refer a patient to an appropriate provider and that Nevada pharmacists are not looking to attain rights outside of their scope of practice.

As the current APhA-ASP and ASHP (Student Alliance) president at USN COP, I was given the opportunity to testify in support of SB 72. I was able to testify about my experiences as a student with regards to health fairs and other community events that student pharmacists attend.

Currently, when student pharmacists volunteer at health fairs, they are able to provide basic screening for diabetes by using a set of standard questions. The patient must then go see a student nurse or EMT to have their blood glucose tested since pharmacists are not permitted to perform the test. Following the test, a student pharmacist, under the guidance of a licensed pharmacist, will consult the patient on the significance of the reading. As a student, it is very frustrating to be able to talk in depth to a patient about their risks for diabetes or managing some of the

complications but not be permitted to actually perform the finger stick.

With continued support from Nevada pharmacists, physicians, diabetes educators, the Nevada Board of Pharmacy, and community members, this bill has the potential for advancing the profession of pharmacy in the state of Nevada. Allowing pharmacists to perform simple finger sticks will serve as a great step forward to improving diabetic patient care in the state of Nevada.

# 2009 USN Patient Counseling Competition

Jeni will go on to represent USN Henderson at the APhA National Patient Counseling Competition at the 2009 APhA Annual Meeting and Exposition in San Antonio, TX from April 3-6. There she will serve as our University's representative competing against 1 student from each College of Pharmacy in the U.S. for a chance to place as 1 of 10 finalists who will compete for monetary awards and an engraved trophy for USN.

We had a large field of competitors, and special congratulations also go out to runner-up P2 Ana Negrete.

Many thanks go out to all the individuals who helped to make this event a success: Holly Prievo, District Pharmacy Supervisor for Walgreens, who along with Lindsay Forrester from Walgreens provided food, and enlisted the support of 6 Walgreens pharmacists to judge the competition. Special thanks also to Dr. Coffman, the College of Pharmacy, and the Student -Alliance for providing Jeni with complementary meeting registration, airfare, and hotel.

For those of you unfamiliar with the competition, it is divided into the preliminary round and final round. In the preliminary round, students select a simple practice scenario at random and are required to counsel a patient on the appropriate use of the drug involved. Students are then given time to refer to the reference sources available in the model pharmacy. After consulting the references and determining the appropriate information for the patient, the participants counsel the patient. Evaluations are based on the content and style of the counseling presentations. The ten highest scoring participants are then invited to the final round.

The final round involves a more complex counseling situation where the participants again select a prescription at random and are asked to counsel the patient on safe and effective drug use. In addition, the patient in the final round will display personality characteristics such as anxiousness, belligerence or apathy to challenge the participants' ability to convey pertinent information in a realistic situation. The top ten finalists in the national competition will be recognized during the APhA-ASP Awards Ceremony and will receive a prize compliments of APhA -ASP. The four top winners of the national competition will alsoreceive prizes.
